#### Who are we?

We are the Ancholme Valley Heritage Trust Ltd, a registered charity (no. 1157731) and company limited by guarantee (no. 8764973), known as Brigg Heritage Centre, With the close support of the North Lincolnshire Council Museums Service we share the artefacts, images and stories of the Ancholme Valley in North Lincolnshire, to both inspire and deepen our audience's understanding of their cultural identity and for the benefit of the wider community.

## How do we collect information from you?
